The organizational meeting of the Board of Trustees of Community College District 535 was conducted virtually on Tuesday, April 27, 2021.

#### Call to Order and Roll Call

Chair Stafford called the meeting to order at 3:01 p.m. Trustees Burns, Salzberg, and Stafford were physically present in room 1506. Trustee Kotowski was absent. Trustee Toussaint arrived at 3:10 p.m. All other trustees attended virtually.

# 4/21-1 Resolution Declaring the Results of April 6, 2021 Consolidated General Election, Community College District 535, Office of Trustee

Trustee Burns offered:

"WHEREAS, on the 6<sup>th</sup> day of April 2021, there was held in and for community College District 535, an election for the purpose of electing two Trustees to serve on the Board for two six-year terms:

WHEREAS, it is the responsibility of the county clerk to canvass the election results 21 days following the election;

WHEREAS, the election authority has delivered the official Abstracts of Votes to the local election official for Oakton Community College District 535;

WHEREAS, the Board must meet to declare the results of the election and hold their reorganizational meeting within the time period of between 21 and 28 days following the election and that the term of the new trustees must commence at the organizational meeting held within 28 days following the election;

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF TRUSTEES OF COMMUNITY COLLEGE DISTRICT 535, COUNTY OF COOK AND STATE OF ILLINOIS THAT:

- 1. The election held on the 6<sup>th</sup> day of April 2021 was held in all respects as provided by law; and the returns of the election have been duly canvassed by the Cook County Clerk's office and filed with the Secretary of the Board.
- 2. The Board finds that the following total votes were cast in Oakton Community College District 535 in favor of the following candidates:"

#### ABSTRACT OF VOTES

"Votes were cast in the non-partisan election held on April 6, 2021, in Cook County, Illinois, to elect three individuals to serve six-year terms on the Board of Trustees of Community College District 535, and we do hereby proclaim the results of the election as follows:

### 4/21-2 Recommendation for Seating of Student Member of the Board of Trustees

Trustee Bush offered:

"SECTION 1: An election for the Student Member of the Board of Trustees was held April 14-21, 2021. The election was conducted in all respects as provided by law and according to Policy 1004. The election was conducted online, using the Simply Voting software purchased by the Student Government Association. Currently enrolled students were provided a ballot via email, and Simply Voting provided a secure method to permit students to vote from their computer or mobile device; 157 students cast ballots in the election.

The returns of the election have been duly canvassed by the Judges of Election. The student meets all qualifications for Trustees as specified in Policy 1004.

SECTION 2: The Board of Trustees declares that Akash Patel received 62 votes (42.8%) for the office of Student Member of the Board of Trustees. His opponents Lydia Cruz receiving 42 (29%), Michael Sobin receiving 27 (18.6%), and Allan Ignacio receiving 14 (9.7%) with 12 (7.6%) abstaining votes cast, thereby declaring Akash Patel the successful candidate to serve as the Student Trustee with a term commencing on April 27, 2021 and concluding at the Board of Trustees meeting in April 2022.

SECTION 3: This resolution shall be effective from and after its passage as provided by law."

#### 4/19-3 Resolution Organizing the Board of Trustees for the Term Commencing April 27, 2021

Trustee Yanow offered:

"WHEREAS, pursuant to College policy and in accordance with the Illinois Public Community College Act, as amended (110 ILCS 805/3-8), the Board of Trustees of Community College District 535 elects its officers comprise of a Chair, Vice Chair and Secretary, from its membership, and appoints a Treasurer, not a member of the Board, at its annual organizational meeting held in April."

#### **Nomination of Officers:**

Chair Stafford asked for nominations for the office of Chair of the Board. Trustee Salzberg nominated Trustee Martha Burns; Trustee Bush seconded the nomination. Chair Stafford asked for a roll call to vote in favor of accepting the nomination of Martha Burns as the Chair of the Board. Trustee Salzberg made the roll call, which passed unanimously.

Trustee Stafford turned the meeting to new appointed Chair Burns. Chair Burns asked for nominations for the office of Vice Chair of the Board. Trustee Stafford nominated Trustee Marie Lynn Toussaint; Trustee Bush seconded the nomination. Chair Burns asked for a roll call to vote in favor of accepting the nomination of Marie Lynn Toussaint as the Vice Chair of the Board. Trustee Salzberg made the roll call, which passed unanimously.

Chair Burns asked for nominations for the office of Secretary of the Board. Student Trustee Patel nominated Trustee Bush who did not accept, and the nomination did not stand. Trustee Toussaint nominated Trustee Paul Kotowski; Trustee Bush seconded the nomination. Chair Burns asked for a roll call to vote in favor of accepting the nomination of Paul Kotowski as Secretary of the Board. Trustee Salzberg called the roll, which passed unanimously.

Trustee Yanow continued:

"NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF TRUSTEES OF COMMUNITY COLLEGE DISTRICT 535, COUNTY OF COOK AND STATE OF ILLINOIS THAT:

- 1. The Board is hereby organized for the term commencing April 27, 2021.
- 2. The time and place for the regular meetings of the Board for the calendar year 2022 shall be fixed as follows:

January 18, February 15, March 15, April 26, May 24, June 28, August 16, September 20, October 18, November 15, and December 13.

Meetings will take place in the Board Room, 1506, at Oakton Community College, 1600 E. Golf Road, Des Plaines, Illinois. Given that the all counties in the State of Illinois continue to operate under a Gubernatorial Disaster Proclamation making in-person meetings not practical or prudent, the time, location and process for accessing the meetings remotely will be published with proper notice and agenda and will be posted as required by law.

3. All Board rules, policies, and procedures in effect during the previous year shall remain in effect.

4. Edwin Chandrasekar is hereby appointed Treasurer to serve at the pleasure of the Board for no additional compensation, provided that before entering upon his duties, the Treasurer shall execute and deliver to the Board a bond, as required by the Illinois Public Community College Act."

Trustee Stafford seconded the motion.

Trustee Bush inquired about meetings that are usually held at the Skokie campus. President Smith indicated that the plan would be to have a physical meeting at Skokie if plans change regarding the Gubernatorial Disaster Proclamation. Trustee Stafford shared his desire to have a discussion to consider earlier meeting start times once they are in person. Trustee Toussaint would like to add a discussion about the possibility of having Zoom meetings when necessary (due to weather or other circumstances). President Smith clarified that the College is only allowed to operate via Zoom for Board meetings while the governor has declared a state of emergency.
